Business owners and other tax and fee payers affected by disasters may request extensions to file returns and request relief from penalties and/or interest. On Nov 30, Governor Newsom announced an automatic 3-month extension – for more details see website.

Main Street / Small Business Hiring Tax Credit - CDTFA | SB1447 Tax Credit | 800-400-7115

Beginning December 1, 2020, CDTFA began accepting applications for small business hiring credit against California state income taxes or sales and uses taxes to certain qualified small business employers that receive a tentative credit reservation subject to availability.

EDD staff are located throughout the state to provide: assistance with filing claims for Unemployment Insurance (UI) benefits, job search assistance, and general support, referrals, and resources.

Taxpayers may deduct a disaster loss for any loss sustained in California that is proclaimed by the Governor to be in a state of emergency.

If your property has been damaged by a recent natural disaster, you may be eligible for property tax relief. In many cases, the damaged property can be reappraised in its current condition, with some taxes refunded to the property owner.
